TERMS & CONDITIONS 2009

NOTE: A parent or guardian responsible for the applicant must agree to and sign a release prior to the camper's participation in any of the summer sessions. If you have submitted a paper or electronic Registration Form, you will have done so already. If you have not, please print this form, sign and return to the Camp Office.

REGISTRATION / PAYMENT PROCEDURES

DEPOSIT: Applications will not be considered unless accompanied by a minimum **\$400** (Residential) or **\$200** (Day Camp, Junior Prep, Pro & Adult Camp) **non-refundable** deposit per camper / per week. Deposits are payable by **Cheque, Visa or MasterCard** (Credit Cards will be charged in Canadian Funds). Cheques should be made out to **Roger Neilson's Hockey Camp**. U.S. checks will be honoured 'at par'. Fax, E-mail and verbal (phone) applications will only be processed when a valid credit card number is provided. Upon receipt of your application / deposit, additional Camp information will be mailed. See CANCELLATIONS / REFUNDS for details on refunds for injuries or illness.

BALANCE DUE: Credit Card payments will be processed **automatically** on May 1, 2009 using the same information as provided unless indicated otherwise with the application. **FINAL PAYMENT IS DUE ON/OR BEFORE MAY 1, 2009**. If registering after May 1st, full payment is required at time of registration. No personal cheques will be accepted past June 1, 2009 – Money orders or Certified cheques only.

Residential Camp fees include all meals & accommodations, on and off-ice activities. They do not include any optional incidental fees such as: spending money, transportation to & from the Camp or weekend stayovers. Day Camp fees include lunch daily and all on and off-ice activities. They do not include any incidental fees such as: spending money, or transportation to and from the Camp. Transportation to & from St. Andrew's College to the Aurora Recreation Complex is included in the price. *Recipients of 'free week' certificates for the Hockey Camp do not qualify for the THN Early Bird subscription.*

Goods and Services Tax (GST) of 5% and Provincial Sales Tax (PST) of 3% will be charged on Residential programs & incidentals (excluding spending money). There is no tax on non-residential (Day Camp, Junior Prep Camp & Adult Camp) program fees.

CANCELLATIONS / REFUNDS NOTE: CANCELLATIONS FORFEIT QUALIFYING SUBSCRIPTIONS TO THE HOCKEY NEWS

PRIOR TO MAY 1, 2009: Original deposits of \$400 (Residential) or \$200 (Day Camp, Junior Prep Camp, Pro & Adult Camp) per camper / per week will be retained as Cancellation Fees. Any additional fees paid will be refunded in whole. There are no exceptions.

AFTER MAY 1, 2009: There are no refunds for cancellations after May 1, 2009 - except for medical reasons. An official Doctor's certificate is required in such cases and must be sent to the Camp Office. **Refunds will be issued in September – following the completion of the Camp season.** All fees paid will be refunded less the original deposit (which will be kept 'on account' for use in the following Camp season).

AFTER THE CAMP SESSIONS HAVE STARTED: There are no deductions or refunds for campers staying off campus, arriving late, leaving early, or missing part of the sessions - except for medical reasons. If the Camp medical staff (including doctors from any Hospital used in Ontario) determines that a camper must leave camp early because of illness or injury, the Camp will provide a 'pro-rated' refund based upon the camper's length of stay less the original deposit. There are no exceptions unless pre-arranged with the Camp Director.

MISCELLANEOUS

Accommodations are not provided during the Day Camp, Junior Prep, Pro or Adult Camp. It is the responsibility of the parent/guardian to drop-off and pick-up the child on time as per the camper's schedule (or to make appropriate arrangements for doing so). The Camp does not accept responsibility for campers who are left unattended beyond the hours listed in the camper's schedule - unless specific arrangements have been made with the Camp Office. Junior Prep, Pro & Adult Camp participants requiring accommodations should contact the Camp Office for additional details.

The Camp does not provide any equipment other than a team sweater. It is the camper's responsibility to ensure they have all equipment necessary to play ice hockey and that the equipment is in good (certified) playing condition (the Camp adheres to CAHA, AHAUS and IIHF guidelines). Roger Neilson's Hockey Camp does not accept responsibility for misplaced, lost or stolen equipment, or personal belongings. All equipment and personal belongings should be clearly marked.

PARENT'S / GUARDIAN'S RELEASE

The Camp Director reserves the right to dismiss a camper when it is determined to be in the best interests of the child and/or the Camp. In the event that a camper is dismissed from Camp, there will be **no refund** of camp fees.

Roger Neilson's Hockey Camp (RNHC) will provide necessary and appropriate supervision of campers. By submitting a Camp application (or signing the Release form), I give my approval to my child's participation in all activities of the RNHC and assume all risks and hazards incidental to such participation and do waive, release, absolve, indemnify and agree to hold harmless, other than for willful default or neglect on their part, Roger Neilson's Hockey Camp, its officers, agents or employees.

I authorize Roger Neilson's Hockey Camp to use my child's photograph in publicity and news releases (including brochures, advertising in print and electronic format) at its discretion. In signing (the application or Release form), I certify that the applicant is in good physical and mental health.

I understand that campers are assigned to teams on the basis of their age, size, and ability to ensure fair competition for all. Every effort will be made to honor teammate requests, however the camp reserves the right to assign campers - as determined to be in the best interest of the of the program and the individual.

I acknowledge that I have read and understand the 'Terms & Conditions' including all Cancellation and Refund Policies and agree to abide by the terms.
